NOTICE INVITING TENDER

TMC&H Authority proposes to engage a Cafeteria Service Operator for providing of different items of hot and cold beverages, bakery items, fast foods, breakfast, lunch, dinner etc. at different prices (found to be reasonable) with hygienic quality.

A space has been allocated for the Cafeteria Service (Presently functioning) located alongside the United Bank of India Branch and the State Bank of India Branch within the TMC&H campus. The allocated space has been substantially refurbished in 2015 to operate the Cafeteria Service. The interested vendors may visit the site before filling the tender during office hours from 10.00 a.m. to 5.00 p.m. to have a preview of the area & facilities allotted for the Cafeteria Service.

Tenders are invited from interested vendors having valid statutory licenses, registrations and 2 years of qualified experience to occupy the designated space for the Cafeteria Service.

Interested vendors may submit their tenders in sealed cover superscribed "**Proposal for Cafeteria Service**" submitting the range of items intended to be offered in line with potential demand & rates of the items and full details of the bidder with copies of supporting documents to Principal cum Chief Superintendent, TMC&H, Tezpur, Tumuki, Bihaguri, Tezpur, Sonitpur, Assam, Pin: 784010 on or before 11-07-2019.

Terms and conditions:-

1. The successful vendor to whom the contract will be awarded will have to deposit a Security Deposit of Rs.2,50,000/- (Rupees two lakhs fifty thousand Only) through FDR/TDR to TMC&H.
2. The Cafeteria Service operator will be provided free water, space on fixed monthly rental basis (Rs. 25,000/- per month until further revision in rent) and electricity charges to be paid on actual consumption basis.
3. TMC&H does not guarantee any quantum of business prospect to the successful vendor as Cafeteria Service Operator opportunity in the establishment. As such, prospective vendors should work out meticulously on this aspect.
4. The contract will be valid initially for 3 years, renewable for a further term of 3 years on performance/ requirement basis.
5. The selected vendor will have to sign a contract agreement with TMC&H before operation of the Cafeteria Service.
6. The Cafeteria Service shall be operated on Pay and eat basis. The amount shall be collected directly from the customers. However, credit facility is to be extended to TMC&H authority on its requirement.
7. The rates offered in the tender for beverage and food items are to be valid during the first year of contract period. After every one year the rates of such items will be reviewed and rates will be fixed on mutual agreement taking into consideration of prevailing market rates at that time. The decision in this regard by the catering committee of TMC&H will be final and binding to both the parties.

8. The Cafeteria Service operator should display the fixed/agreed rates of all items offered for sale in the Cafeteria Services.
9. The Cafeteria Service operator should/will be responsible for cleaning and regular upkeep of the allocated space.
10. No liquor items will be provided/ served in the Cafeteria Services.
11. Sub-Leasing of the Cafeteria after award of contract will not be permitted.
12. TMC&H's aspiration is to engage a Cafeteria Service Operator who would be able to provide a high quality of service which offers a range of beverages and food items in line with potential demand providing its prospective customers with a choice of products and on a value for money basis. TMC&H's selection of successful vendor shall be in the TMC&H's sole discretion and shall be final. TMC&H does not bind itself to accept any particular tender. Correspondence will be entered into with the successful vendor.
13. The Cafeteria Service operator will have to take prior approval of the TMC&H authority on the publicity related matters of the Cafeteria Service.
14. This tender document will become a part of the contract agreement.
